By signing here, I commit to regularly practice the music scheduled for performance by ASO, and to regular and prompt attendance at rehearsals and performances, and to the assumption of risk.

Assumption of risk: I acknowledge that participation includes possible exposure to and illness from infectious diseases including COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist and I knowingly and freely assume all such risks, in addition to the risk of injury, harm and loss associated with this activity.

Conditions of Participation:

1. Advance Registration is required. We will use memberships, as we have in the recent past. Membership dues will be required, unless a waiver is requested. Membership dues are not a set amount. We recommended \$100 per year before Covid 19. Since many players paid for 2020 and received the benefit of only a partial year, and since 2021 will only be a partial year, we are recommending \$50 dues for 2021. Only persons on our membership list will be allowed in the door at rehearsal.
2. Proof of vaccination or negative Covid test within 7 days is required at the door, or in advance with your registration.
3. Masks must be worn whenever possible.
4. Physical distancing of a minimum of 6 feet for all individuals with masks, and a minimum of 12 feet for wind instrument players. If wind instrument players have covers for their instruments to prevent transmission of airborne water droplets and particulates, we ask that they be used.
5. Sheet music will be available digitally for you to print yourself, or to use electronically. Paper sheet music will be provided only by advance reservation for those without electronic access. We will resume rehearsals with the music we were working on in March of 2020, so many players will still have that music.
6. The rehearsal hall may be cold because we will rehearse with doors and windows open.
7. No-touch thermometers will be used to take temperatures of all individuals entering.
8. No snacks or drinks will be provided. If you need to eat or drink during a 2 hour rehearsal, bring your own. That includes water.
9. No spectators are allowed.
10. We are hopeful that we may be able to relax some of these conditions and restrictions by mid August.

Summer participation: ASO traditionally has taken one month hiatus in the summer. Because we have just had a 14 month long hiatus, it is our intention to hold rehearsals throughout the summer this year.
